ArtsForward Grant Guidelines

This funding provides direct support to nonprofit organizations and individuals applying through a nonprofit fiscal sponsor. Projects must be new work, align with at least one priority of the Akron/Summit Cultural Plan, and benefit Summit County communities. Applicants may request up to \$25,000. Eligible projects can include, but are not limited to:

- Arts festivals, music, dance, literary or theatrical performances, or workshops.
- Art, movement, literature/poetry, or music therapy programming.
- Writing or visual art activities.

Eligibility Requirements*

- The proposal must advance one of the ten priorities of the Akron/Summit Cultural Plan
- The project takes place within Summit County
- Qualify as one of the following entities eligible for application:
 - o Nonprofit or community organizations holding a current **tax-exempt status under Section 501(c)(3)** of the Internal Revenue Code
 - o Recognized governmental entities including state, county, or city agencies such as health departments
 - o Educational facilities, such as K-12 public, private, or charter schools or school districts and higher education institutions
